If any information contained in the foregoing affidavits or revised affidavits was false at the time the affidavit or revised affidavits were executed or if the Bidder/Proposer, assignee, or subcontractor fails to notify the Purchasing Agent of a change and provide revised affidavits as required above, then the contract, assignment, or subcontract, as the case may be, shall be null and void as to the Board, and the Board shall be entitled to recover any and all money paid on the contract, assignment, or subcontract.)
